Relocation Addendum Effective 3rd January 2019 / Terms & Conditions



This document sets out additional terms and conditions that apply to relocation bookings with Apollo Motorhome Holidays Pty Ltd (**Apollo**) (**Relocation Terms**). The Relocation Terms and the terms and conditions set out in your associated rental agreement with Apollo (**Rental Agreement**) are legally binding on you on and from the date on which you sign them. If the Relocation Terms are inconsistent with the Rental Agreement, the Relocation Terms will apply to the extent of any inconsistency. All rates quoted are in Australian dollars.

Your Obligations

By accepting the Relocation Terms, you agree and acknowledge that:

- driver fatigue or drowsy driving is a safety hazard;
- the main causes of fatigue are not enough sleep, not allowing enough downtime between drives and other travel arrangements, driving at night (when you should be asleep) and working or being awake for a long time; and
- it is important to be aware of the signs of fatigue.

Accordingly, you must not at any time while driving any vehicle owned or leased by Apollo or otherwise available for hire through Apollo's services:

- break any law or regulation that relates to the use of vehicles on roads;
- exceed any applicable speed limit; or
- drive any vehicle while impaired by fatigue.

Rental Duration & Free Mileage

Subject to availability, the maximum number of included days for each route are set out in the table below.

The number of free kilometres included in your relocation booking for each route are also shown in the table below. If you exceed the number of included kilometres set out below, you will be charged \$0.32/km for each kilometre in excess of those set out in the table below.

Vehicle Pick-up

Relocation bookings are to be picked up after 2pm unless specified otherwise on your booking confirmation.

Vehicle Return

Relocation bookings are to be returned by 11am on the last day of rental unless specified otherwise on the booking confirmation. Late returns and no-shows will be charged double the daily standard rental rate applicable for each day post the contracted return date as outlined on the rental agreement.

Transfer

For relocation bookings, the vehicles must be collected and returned to our branches (not airports). Transfers to and from the Apollo branch are not included in the rental price. It is your responsibility to get to and from the branch.

Inclusions

The Broome Fee, One Way Fee and Pre-purchased Gas Bottle Fee (each of which are set out in) do not apply to relocation bookings. Any gas bottles supplied with the vehicle will be supplied full and can be returned empty to Apollo at the completion of the rental.

Driver's Licence and Minimum Age

An original, current and full motor vehicle driver's licence is required to be presented at the time of pick up by all drivers. If the driver's licence is not in the English language then an international driver's licence is also required. An accredited English translation will be accepted in lieu of an international driving licence. All driver's licences must be open licenses with no restrictions, have been held for at least two years and be valid for the whole length of the rental.

Drivers must be 21 years of age or over for all relocation bookings, including "Hippie" relocations.

Additional Driver/Renter Fees

Additional Driver/Renter Fees are included in the price.

Kitchen and Personal Kits (Campervan and Motorhome relocations only)

Pillow cases, sheets, towels, duvets and covers are included in the price for relocation bookings.

Travel Restrictions

For relocation bookings, all vehicle types (incl. 4WD vehicles) can only be driven on sealed/bitumen roads or well-maintained access roads less than 500 metres long to recognized campgrounds. For relocation bookings, night driving (from dusk to dawn) is not permitted and you must take appropriate rest breaks between periods of driving to ensure that you do not drive while fatigued:

- To avoid driver fatigue it is advised that for every 2 hours of driving you take a 15-minute break and drive a maximum of 12.5 hours each day.

While you are on a relocation booking, if you are found to be driving on unsealed roads, driving in restricted areas, night driving (from dusk to dawn), or driving while fatigued, you will be fined \$1500 by Apollo, even if no damage has occurred to the vehicle. This applies to all relocation bookings including those where extra days have been purchased.

Cancellation of Booking/Change of Vehicle

For relocation bookings, in the event of unforeseen circumstances beyond our control rendering the booked vehicle type unavailable, we reserve the right to substitute a different vehicle type, or cancel the relocation booking and refund your deposit. This shall not constitute a breach of contract. You are only entitled to cancel the relocation booking and have your deposit refunded if the substituted vehicle type offered is unsuitable due to it having less seatbelts than the vehicle you originally booked.

If you cancel your booking or fail to pick-up the vehicle you will be charged the following fees:

- if you cancel within 12 hours of you making the booking but not on day of pick-up, **no fee**;
- if you cancel 12 or more hours after you making the booking but not on the day of pick-up, **\$250**; or
- if you cancel on the day of pick-up or you do not show up for pick-up, **\$250**.

Amending an existing relocation booking to a different relocation booking is considered a cancellation of the existing booking and cancellation fees apply. There is no refund for late pick up or early return of vehicle.

Extra Days

Up to 3 extra days can be booked at a flat fee of \$100 per extra day and are subject to availability. Any additional extra days can be booked at our flex rates subject to availability. Please check with our reservations team for latest availability and flex rates. Each extra day booked includes an extra 300 free kms. The Relocation Terms continue to apply for extra days.

Free Offers

Should the chosen relocation booking involve an offer or allowance, please ensure this is noted on your contract at pick-up. Depending on the offer or allowance included in your booking, we may credit to your credit card the cost of fuel used (receipts required) and any applicable travel allowance (no receipts required) on return of the vehicle, up to the amount noted on the contract. Where receipts are required, the receipts must clearly state the cost of the item purchased and include a description of the item purchased. Credit card receipts are not sufficient. These offers are only redeemable when the vehicle is returned to the correct location on time, has not been involved in an accident, is full of fuel, and all other terms of the Rental Contract have been complied with.

Pay First Tank and Return Empty offers

Should your relocation booking include a "pay first tank offer", you will receive the vehicle with a full tank of fuel and will be charged a refill fee at pick-up. You can return the vehicle with the fuel nearly empty.

Free Ferry offers (relocations from/to Hobart)

Should your relocation booking include a "free ferry offer", Apollo will book the cheapest available ferry crossing and will cover the cost of the vehicle and driver. Any costs associated with additional passengers are at your expense. Once you have made your booking, please contact Apollo for the booking number for your ferry crossing. Any accommodation or passenger detail changes can then be made directly with Spirit of Tasmania (Ferry operator) on 1800 634 906.

Standard Liability and Bond

Apollo's Backpacker relocation booking rental charge includes a Standard Liability of \$1,000 in the event of an accident and in accordance with our Rental Agreement Terms and Conditions. A Bond of \$1,000 will be collected at the time of entering into the Rental Contract. Payment of this Bond is only accepted by credit card. The \$1,000 will be debited to the credit card account immediately. An administration fee equal to the merchant surcharge applies.

The Standard Liability can be reduced by purchasing the following Reduction Option:

Option 1: A Liability of \$250 applies. This Option can be purchased by paying to Apollo \$20 per day. Payment of this Bond is only accepted by credit card. The \$250 will be debited to the credit card account immediately. An administration fee equal to the merchant surcharge applies.

Please note: You are liable for overhead and underbody damage caused by/to the vehicle regardless of cause, except where there is a collision with another vehicle. No liability reduction option purchased/chosen covers damage caused by/to tyres, windscreen, slide out, overhead or underbody of the vehicle or damage/accidents occurred from dusk to dawn.
